

# HIGHLIGHTS: DONOR IMPACT AT UM

#### SUPPORT FOR UM STUDENTS

Together, our UM Foundation giving community transforms lives through scholarships, allowing the University to provide essential support to students with financial need and to attract students who demonstrate academic merit.

Over \$6.8 million in privately funded scholarships was awarded to UM students in FY 2024.

The University of Montana is expanding the **Payne Family Impact Scholarship** to assist students whose families don't have the resources to pay for college, but whose income is above the threshold for large financial aid packages such as Pell Grants. The program was established by an extraordinary gift from Terry and Patt Payne in 2021. In 2024, the Payne family committed an additional \$7.5 million to expand this program and help even more students pursue their dreams at UM. UM has already awarded more than \$1 million in Payne Family Impact Scholarship funds to students for the 2024-25 academic year. **Learn more**.


our giving community came together in January 2024 to send the **Grizzly Marching Band** on a historic trip to Frisco, Texas, to support the Grizzly Football Team at the 2024 FCS National Championship. Over 1,100 supporters contributed more than \$131,000 to help UM's student musicians provide an unforgettable game day experience for Griz fans. Students from all majors can participate in the Grizzly Marching Band, and members invest hundreds of hours in the fall to ensure Washington-Grizzly Stadium has the best gameday atmosphere in the nation.



#### LEARNING ENVIRONMENTS AND FACILITIES

Treasure Montana: Cultivating Our Tomorrow, a campaign that aims to inspire \$20 million in private support to build Montana's new hub for environment and conservation on campus. This initiative is intended to support one of UM's areas of strength and ensure that the University realizes a \$25 million state funding match opportunity. More than just a building, the facility will be a stage where critical conversations become real-world solutions led by the Franke College, a recognized leader in safeguarding and sustaining Montana's vibrant landscapes, natural resources and ecosystems. Learn more.

In FY 2024, the University opened the donor-supported Montana Museum of Art and Culture building. Art lovers from both campus and the community have enjoyed the new 17,000 square-foot permanent home of the museum since its opening last fall. The Grizzly Indoor Practice Facility opened this fall after a successful fundraising initiative to raise \$10.2 million from over 170 donors. The new facility is a center of activity that will serve Grizzly Athletics, UM intramural and club sports, and community members for generations to come.




#### **ELEVATING ACADEMIC PROGRAMS**

n 2024, the UM Foundation completed a \$5 million fundraising effort to endow a chair in fisheries science from UM's wildlife biology program. In just over two years, more than 50 donors including Ken Siebel, Huey Lewis, the late Gordon Moore, the Tykeson Family Foundation and the Trailsend Foundation, joined together to establish the **Siebel-Lewis Endowed Chair in Fisheries Science**. The endowment will provide annual funding for a critical faculty position in the Wildlife Biology Program, building on the program's already impressive fisheries research and expanding UM's focus on training new generations of fish conservationists and biologists. Learn more.

Project, a research and multimedia initiative at the University of Montana, is spotlighting the intricate web of life in the Greater Yellowstone Ecosystem, ranging from bison and grizzly bears to songbirds and osprey. A major gift from Joe Ricketts' Jackson Fork Ranch to the University of Montana Foundation is funding a multiyear collaboration that seeks to better understand biodiversity in the 34,375 square-mile ecosystem spanning Wyoming, Montana and Idaho, with Yellowstone National Park at its center. The UM Foundation received an \$8 million grant from The ALSAM Foundation in August 2023 to expand the influence of the **L.S. Skaggs Institute for Health Innovation** and improve access to innovative healthcare for all Montanans. In addition to The ALSAM Foundation's investment, donors to the UM Foundation contributed an additional \$2 million in support of the institute. The extraordinary vision of The ALSAM Foundation and UM donors enables the College of Health and SIHI to provide equitable and high-quality care across our state. **Learn more**.



#### **EVERY GIFT MATTERS**

Over 24 hours in March 2024, 871 donors united across nearly all 50 states to give \$659,463 during our fifth-consecutive record-breaking giving day, **The Big Give**. Donors' collective generosity championed opportunities for students and faculty in every UM school and college. Nearly 300 students voted to select the UM Food Pantry to win the Students' Choice Award. The food pantry received a bonus gift of \$1,000.

The scholarship, honoring Bryce's grandfather and Erika's grandmother – both of whom passed away in 2022 – allows the Burkes to carry forward their legacies and values. The Burkes structured their giving to take advantage of the Qualified Endowment Credit, which helped ease their state tax burden while also honoring their grandparents' spirit of philanthropy.
